

1. Promoter

The promoter is MERIMBULA RSL CLUB LTD ABN 66 000 965 560, a registered club under the Registered Clubs Act 1976 (NSW), located at 52-54 MAIN ST, MERIMBULA NSW 2548 ("Promoter").

2. Promotion Name

Friday Night Members Draw ("Promotion").

3. Promotion Period

The Promotion is conducted weekly each Friday night between **4.00pm** and **6.45pm** ("Promotion Period").

Each weekly draw is a separate and independent trade promotion.

4. Eligibility

Entry is open to current financial members of the Promoter who are aged 18 years or over.

Directors, committee members, officers and employees of the Promoter are eligible to enter provided they are not on duty, not rostered to work, and not involved in the conduct, administration or determination of the Promotion at the time of entry or the draw.

Any person directly involved in the conduct, administration or determination of the Promotion at any time is not eligible to enter.

5. Method of Entry

Entry into the Promotion is free.

To receive one (1) entry into that week's draw, an eligible member must spend \$10 or more in one (1) or more transactions on food and/or beverages only, processed through the Promoter's bar, café or restaurant point of sale systems, during the Promotion Period.

A maximum of (1) entry will be awarded per transaction during the Promotion Period.

One (1) additional entry will be awarded for every additional \$10 spent during the Promotion Period.

Spend on Keno, TAB or wagering transactions, bottle shop or takeaway alcohol sales, or any other non-food and beverage retail or gaming transactions does not qualify for entry.

6. Draw Details

- The draw will be conducted at **the conclusion of raffles** each Friday night in the **Scenic Lounge**.
 - The winner will be determined by a random draw from all eligible entries received during the Promotion Period.
 - The draw will be conducted manually by random selection from the pool of entries by staff conducting the raffles.

7. Prize

- One (1) prize will be awarded each week, being a \$200 club card / club voucher.
 - The total prize value per draw is \$200 (AUD).
 - The prize is not transferable and is not redeemable for cash.
 - Any conditions, restrictions or expiry dates applicable to the club card or voucher will be advised at the time the prize is issued.

8. Must Be Present to Win

The selected winner must be present at the club premises at the time of the draw to be eligible to claim the prize.

Upon being announced, the selected winner will have a minimum of **four (4) minutes** to present themselves to claim the prize. The staff member conducting the draw may, at their sole discretion, extend this time where they consider it reasonable or appropriate before drawing the next entry.

If the selected entrant does not present themselves within the applicable claim period:

- the entry will be deemed invalid; and
- a subsequent draw will be conducted immediately from the remaining eligible entries to determine a new winner.

This process will continue until an eligible member who is present and claims the prize is selected.

9. Winner Notification

The winner will be announced immediately following the draw.

The winner must provide proof of identity and valid club membership to the satisfaction of the Promoter before the prize is awarded.

10. General Conditions

- The Promoter reserves the right to verify the validity of entries and entrants.
 - The Promoter may disqualify any entrant who tampers with the entry process or who submits an entry not in accordance with these Terms and Conditions.
 - The Promoter's decision in relation to all matters arising from the Promotion is final and binding.

12. Compliance Statement
